I talked to Stephen Walters with GLS Insurance (our insurance broker).

He finds it hard to believe that they can't get event insurance for these walkthroughs.

Even though they are claiming to be self-insured, Stephen is suspecting they are self-insured on *property* but most likely not self-insured on *liability*.

He says it is highly unlikely that the State would allow them operate self-insured on liability.

In this day and age, insurers are experiencing an increase in "slip & fall" claims. We live in a very litigious society. Stephen says he sees it all the time from his vantage point.

Given that the Winter Wonderland walkthroughs are held in November and December and when it gets dark, it is not hard to imagine that someone or some persons might legitimately or falsely injure themselves in our parking lot and claim insufficient lighting, uneven pavement, unsafe conditions, or improper clearing of ice & snow. McKnight Crossings would be held liable in these cases, for an event we are not organizing or sponsoring.

If we don't stand firm on requiring the St. Louis County Parks provide <u>their own</u> liability insurance for Winter Wonderland walkthroughs that covers their use of our parking lots, I don't see how we can accommodate their request without putting McKnight Crossings at unnecessary risk for injury lawsuits. It seems a very reasonable request for them to acquire event insurance so any incident on our parking lot is covered by their insurer and not ours.

Stephen says event insurance for the Parks department should not cost too much. He doesn't understand their claim that they can't purchase it, as schools (another public entity) do so all the time. He suspects they just don't want to own the liability.
